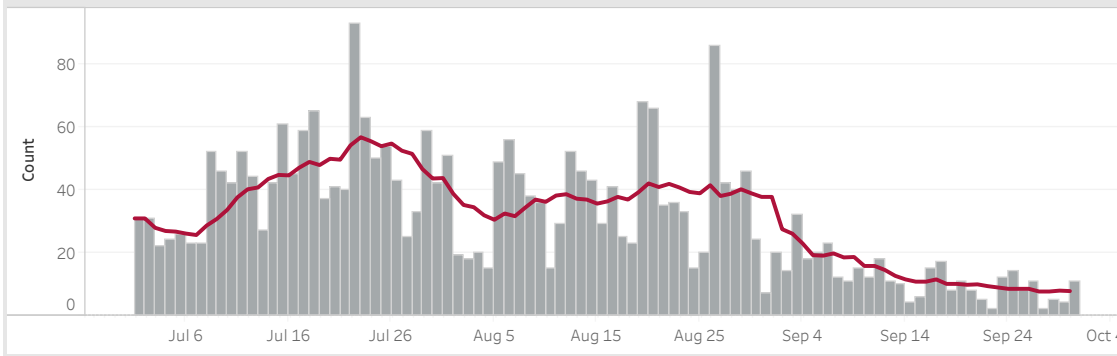

1. A confirmed case is defined as detection of SARS-CoV-2 in a clinical specimen using a diagnostic test. A new case is defined as a positive test within the monthly reporting time period. A delayed case is defined as a positive test from previous month(s) of the monthly reporting time period. 2. A confirmed death is a death certificate that lists COVID-19 disease or SARS-CoV-2 as an underlying cause of death. 3. Up-to-Date Vaccine: Persons who have received their COVID-19 vaccines if they have the most recent COVID-19 vaccine recommended by CDC. Everyone aged 6 years and older should get 1 updated Pfizer-BioNTech or Moderna Covid-19 vaccine to be up to date. Children aged 6 months to 5 years may need multiple doses of COVID-19 vaccine to be up to date, including at least 1 dose of the updated Pfizer-BioNTech or Moderna Covid-19 vaccine. To reflect the CDC definition changes for being up to date, we will only report on percent of residents who are up to date with their vaccines. We will no longer report on the percent of people who are partially vaccinated or who have completed a primary series at this time. 4. Hospitalization rate = COVID admissions per 100K people. 5. Monthly counts are subject to change as additional delayed case notifications are received.
